INSTRUCTIONS:

Participants in the Breeder Excellence program must establish and maintain a written emergency protocol that outlines the methods used for the need to evacuate, repair, or recondition their breeding facility. The protocol must also establish a means for physical movement, mobile transportation and housing of animals in the event of an emergency situation.

The protocol must be submitted to the Minnesota Board of Animal Health (Board) either by mail or e-mail to <u>companion.animal@state.mn.us</u>. The emergency response plan must be made available to an agent of the Board at the time of inspection.

Animal evacuation plans

Describe your plans for evacuating animals from your breeding facility. Include physical evacuation plans as well as options for mobile transportation and alternate housing accommodations if needed.

List supplies and quantity required in the event the entire kennel needs to be evacuated. Include enough supplies for a minimum of 24 hours (i.e. lbs. of food, water, carriers/kennels, leashes).

Describe your plans for arranging veterinary care in the event that a significant number of animals are injured or become ill during a disaster or a disease outbreak occurs.
